### Tasks for BRPs:

- Check access to eSett's Online Service in Production environment (<u>https://online.esett.com/ONLS.Private/Login</u>)
- □ Create necessary users for your company (Administration » Users)
- Check that Company and Market Party information are filled and correct (Administration » Market Party Detail / Company Detail)
  - Name, code, business id, contact information, VAT, invoice details (email/electronic) etc.
  - <u>Note</u>: Invoice currency, settlement account, and fiscal status won't be visible until 1.2. and production timeseries until first reporting on 3.2.
- Check that *Channel of Electronic Communication* is filled and correct (Administration » Market Party Detail)
- Check that Settlement Account has been added and is correct (Administration » Market Party Detail » Accounts)
  - Request also for a Release Account if it's missing
- □ Subscribe for relevant data packages (Reports » Data Packages Management) if you wish to receive data from eSett

#### Week 4

- BRPs should start reporting Bilateral Trade values to eSett latest on Sunday if any exists
  - Bilateral trades can be reported up to three months before the delivery day and latest 20 minutes before delivery hour
  - For example, reporting for hour 1.2.2021 00-01 CET must be done before the gate closure, so latest at 31.12.2021 23:40 CET
  - Reporting of the bilateral trades will be a continuous process from this point onwards
  - For more information: see NBS Handbook chapter 5.4.1.3 Bilateral Trade Reporting
  - Task: start reporting and check that your reporting for week 5 is successful if you have bilateral trades

### Sunday 31.1.2021:

- NEMOs will report, for the first time, day-ahead trades regarding Denmark to eSett for delivery date 1.2.2021
  - This will continue as a daily process from 31.1. onwards
- BRPs can stop reporting day-ahead nominations to Energinet concerning February
- **BRPs** can stop reporting Intraday nominations to Energinet concerning February

#### Monday 1.2.2021

- **NEMOs** will report, for the first time, intraday trades regarding Denmark to eSett for delivery date 1.2.2021 and will continue daily
- Energinet (TSO) will report, for the first time, production plans (actor plans concerning production) for Denmark for the open settlement period\* to eSett and will continue daily
- Energinet (TSO) will report, for the first time, imbalance prices for Denmark for the open settlement period\* to eSett and will continue daily

#### Tuesday 2.2.2021:

Energinet (TSO) will report, for the first time, activated reserves for Denmark for the open settlement period\* to eSett and will continue daily

#### Wednesday 3.2.2021:

- Energinet DataHub will report, for the first time, metered data (production, consumption etc.) for Denmark for the open settlement period to eSett and will continue daily
  - This will also trigger the creation of Merged Production time series in eSett's system

\*Open period covers 13 days to the past, except in the beginning of February where it covers only backwards to the date 1.2.2021 20 January 2021

### Monday 22.2.2021

- BRPs receive invoices for week 5 (1.2.-7.2.2021) by 13 CET
  - Sent as E-invoice or via email
  - Available in Online Service as PDF and XML (Finances » Invoices)
  - Contact eSett as soon as possible if there are any issues with the invoice
- **BRPs** to provide sufficient balance on settlement account <u>during Monday</u> if the invoice is a debit note

### Wednesday 24.2.2021:

• eSett direct debits the settlement account of the BRPs that received debit notes

### Thursday 25.2.2021:

• eSett makes payments to BRPs that received credit notes to the settlement account
