



eSett Notifications

For Online Service and Email

Basic information

- Notifications contain various types of information for market participants regarding the Nordic Imbalance Settlement
- Notifications are available for Balance Responsible Parties (BRP), Balancing Service Providers (BSP), Distribution System Operators (DSO), and Retailers (RE)
- There are two distribution channels depending on the notification:
 - Online Service notifications
 - Email notifications
- The list of available notifications is displayed in Online Service under Reports > Notification Management
- Notifications are subscribed to at the user level
- Users will only receive notifications for the company to which they belong
- Each notification has a different triggering logic when it is sent out to the user
 - The event that triggers the notification can be viewed in Notification Management

How to modify your notifications

- Users can manage their subscriptions to available notifications by accessing the Reports > Notification Management view in Online Service
- To subscribe or unsubscribe from a single notification: press the button on the right-hand side of the specific row

- If you want to quickly subscribe or unsubscribe to multiple notifications, you can utilize the “Business Process Subscription” option
- Note! To receive notifications via email, you must insert the Notification Email address in “My Profile” in Online Service. Access “My Profile” by clicking on your name in the upper corner of the page.

Where to see your notifications in Online Service

- There are three different ways to view your notifications:
 1. Notification Widget on the Dashboard (front page)
 - Provides an overview of the latest notifications received
 2. Unread Notifications
 - The number represents the total number of unread notifications for the user
 - The list of Unread notifications is accessed by clicking the red number next to your name in the top right-hand corner of the page
 - Any notification displayed here will automatically change its status to "Read," and it will no longer be counted towards the total number of unread notifications
 3. View Messages > Notifications Overview
 - Displays all notifications that the user has received
 - Here the user can filter the notifications to search for past notifications
 - By using the "Mark all as read" process, users can quickly reduce the number of notifications with the "Unread" status
